PUBLIC CONSULTATION 2022

Guidance Note

Introduction

The Wyre Local Plan 2031-2031 Partial Review (now referred to as a Partial Update) was submitted to the Secretary of State for Examination on 25 April 2022. Hearings took place on the 27 and 28 September 2022. During the examination, including the hearing sessions, the Planning Inspector has identified a number of Main Modifications (MM) that are necessary to make the Plan sound. This is without prejudice to the Inspector's final conclusions and recommendations.

In accordance with the request of the Inspector, Wyre Borough Council has published its proposed Main Modifications to the Publication Draft Wyre Local Plan (2011-2031) (incorporating partial update of 2022) (referred to below as simply "the Plan") for public consultation.

The consultation period is from <u>Wednesday 12 October 2022 to 5pm Wednesday</u>

23 November 2022 inclusive. Please note that representations can only be received during the consultation period. Late representations <u>cannot</u> be accepted.

The proposed Main Modifications are presented in the form of a schedule. Within the schedule each modification is given a reference number. It is important that when commenting on a main modification you quote the relevant reference number (or numbers if you are commenting on more than one proposed modification). Alongside the proposed Main Modifications, the council is also publishing a Schedule of Additional Modifications. These are minor amendments such as addressing typographical errors or changes. The Additional Modifications are not the subject of public consultation as they do not affect the "soundness" of the plan.

This guidance note has been produced to assist you with making representations on the proposed Main Modifications to the Local Plan.

Local Plan Legal Compliance

The Inspector has considered the matter of legal compliance as part of the examination process. This includes a consideration of representation already made on this matter. His final conclusions regarding soundness and procedural compliance will be set out in the report to be produced following consultation on the proposed Main Modifications. You should consider the following before making a representation on legal compliance:

- The process of community involvement for the proposed Main Modifications should be in general accordance with the Statement of Community Involvement (SCI). The SCI sets out the strategy for involving the community in the preparation of the Local Plan.
- The Local Plan should comply with the Town and County Planning (Local Planning)
 (England) Regulations 2012 (the Regulations). On publication of the Proposed Main
 Modifications, the council must publish the relevant documents, making them
 available on its website and at its principal offices. It must also notify the Local Plan
 bodies (as set out in the Regulations) and any persons who have requested to be
 notified.

The Statement of Community Involvement is available from the examination library at the above web link for the consultation or by contacting the Planning Policy Team (see below).

If you consider the Main Modifications to the Local Plan not to be legally compliant, please state clearly your reasons and explain how legal compliance can be achieved. Please refer to specific Main Modification reference numbers if required.

The Schedule of Proposed Main Modifications includes a statement on the Sustainability Appraisal and technical assessments.

Main Modifications and the Test of Soundness

The proposed Main Modifications generally take the form of changes, deletions or insertions to policies and supporting text.

The proposed Main Modifications have been made to make the Plan "sound". Through the examination the Inspector will consider whether or not the Plan passes the test of "soundness" set by the government's National Planning Policy Framework 2021 (paragraph 35). To be found sound a plan has to be:

- Positively prepared This means that the Plan should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is practical to do so and consistent with achieving sustainable development;
- Justified The Plan should be the most appropriate strategy when considered against reasonable alternatives, based on proportionate evidence;
- Effective The Plan should be deliverable over its period and based on effective joint working on cross- boundary strategic matters;
- Consistent with national policy The Plan should enable the delivery of sustainable development consistent with the National Planning Policy Framework and other relevant statements of national policy.

Making Your Representation

Your representation should cover succinctly all the information, evidence and supporting information necessary to support/justify the representation and any suggested further modification.

It is important to note that representations can only be made in relation to the proposed Main Modifications and any legal compliance and soundness issues they raise. There is no need to repeat any previously submitted representation, nor can the council accept comments on aspects of the Plan not subject to a Main Modification.

Representations received relating to the proposed Main Modifications will be submitted to the Inspector for his consideration.

Please note that your representation **must** include your name and address plus an e-mail address if you have one. If you are representing an organisation please provide its name.

It is not possible for representations to be considered anonymously.

If you are an agent completing this form on behalf of a client, please provide in full your details and the name, address and post code of your client. Where an agent is representing a client, all correspondence will be sent to the agent.
