

**NOTICE OF PUBLIC PATH ORDER
TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257 AND PARAGRAPH 1 OF
SCHEDULE 14**

**WYRE BOROUGH COUNCIL (DIVERSION OF POULTON-LE-FYLDE FOOTPATH 2 (PARTS) AND
POULTON-LE-FYLDE FOOTPATH 3 (PART) OFF GARSTANG ROAD EAST) ORDER 2018**

The above order was made on 27th September 2018. The effect of the order will be to divert part of Poulton-le-Fylde Footpath 2, on land opposite Poulton New Cemetery, running from a point approximately 50 metres east of Little Poulton Lane at SD 3589 3960 (point A) running generally south east for 615 metres to its junction with Garstang Road East SD 3642 3934 (point D) and part of Poulton-le-Fylde Footpath 3 from SD 3650 3943 (point E) running south west for 120 metres to its junction with Poulton-le-Fylde Footpath 2 at SD 3641 3936 (point C) to a new line starting at the same point at SD 3589 3960 (point A), running generally south for 250 metres to point SD 3586 3936 (point F) then generally east north east for 665 metres to (SD 3644 3952) point G, then generally south south east for 180 metres to join Garstang Road East at SD 3652 3937 (point H), as indicated on the order map.

A copy of the order and the order map may be seen free of charge at the Civic Centre, Breck Road, Poulton-le-Fylde FY 7PU from 9 am to 5pm on Mondays to Fridays. Copies of the order and map may be bought there at the price of £2.

Any representation about or objection to the order may be sent or delivered in writing addressed to Legal Services, Senior Solicitor, Wyre Borough Council, Civic Centre, Breck Road, Poulton-le-Fylde, Lancashire FY6 7PU not later than 2nd November 2018. Please state the grounds on which it is made.

If no such representations or objections are duly made, or if any so made are withdrawn, Wyre Borough Council may itself confirm the order as an unopposed order. If the order is sent to the Secretary of State for Environment, Food and Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.

WYRE BOROUGH COUNCIL (DIVERSION OF POULTON-LE-FYLDE FOOTPATH 2 (PARTS) AND POULTON-LE-FYLDE FOOTPATH 3 (PART) OFF GARSTANG ROAD EAST) ORDER 2018

This Order is made by Wyre Borough Council under section 257 of the Town and Country Planning Act 1990 as amended because it is satisfied that it is necessary to divert the footpaths to which this Order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 as amended namely: Planning Permission No. 15/00298/LMAJ for a residential development comprising 516 dwellings (27 five-bed dwellings, 160 four-bed dwellings, 238 three-bed dwellings, 91 two-bed dwellings) including 30% affordable homes, landscaping and associated infrastructure including two new access points off Garstang Road East and new footpaths at land north of Garstang Road East, Poulton-Le-Fylde, Lancashire

BY THIS ORDER:

1. The footpaths over the land shown by bold black lines on the attached map and described in Part 1 of the Schedule to this Order ("Schedule ") shall be diverted as provided in Part 2 of the Schedule.
2. There shall be created to the reasonable satisfaction of Lancashire County Council alternative highways for use as a replacement for the said footpaths as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
3. The diversion of the said footpaths shall have effect on the date on which Lancashire County Council certify that the terms of Article 2 above have been complied with.
4. Where immediately before the date on which any footpath affected by this Order is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

SCHEDULE

All lengths and compass directions are approximate and points are as indicated on the attached map.

PART 1

Description of site of existing paths or ways

- a) That part of Poulton-le-Fylde Footpath 2 (the entire width) from point A (SD 3589 3960) running generally south east for 440 metres to point B (SD 3630 3947).
- b) That part of Poulton-le-Fylde Footpath 2 (the entire width) from point B (SD 3630 3947) running south east for 155 metres to point C (SD 3641 3936) then south south east for 20 metres to its junction with Garstang Road East at point D (SD 3642 3934).
- c) That part of Poulton-le-Fylde Footpath 3 (the entire width) from point E (SD 3650 3943) running south west for 120 metres to point C (SD 3641 3936).

Part of the route of Poulton-le-Fylde Footpath 2 at point B is not to be extinguished, being a section of approximately four square metres. It is advised that this small section is needed as part of the alternative route of Poulton-le-Fylde Footpath 2.

PART 2

Description of site of alternative highway

- (a) A footpath 3.5 metres in width from point A (SD 3589 3960) running generally south for 250 metres to point F (SD 3586 3936) then generally east north east for 480 metres to point B (SD 3630 3947).
- (b) A footpath 3.5 metres in width from point B (SD 3630 3947) running generally north east for 185 metres to point G (SD 3644 3952) then generally south east for 115 metres to point E (SD 3650 3943).
- (c) A footpath 3.5 metres in width from point E (SD3650 3943) running south for 65 metres to join Garstang Road East at point H (SD 3652 3937).

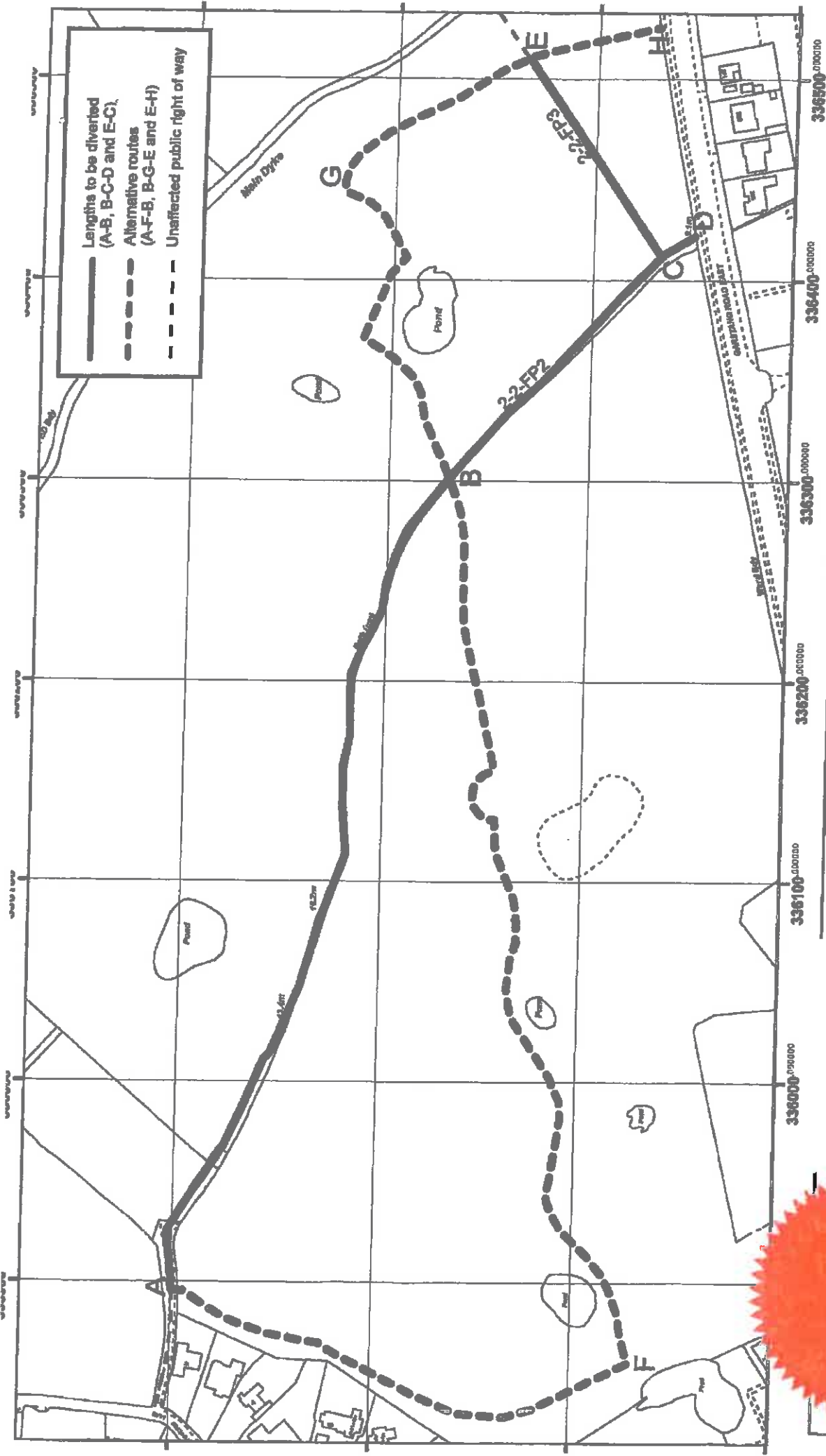
