

Wyre Local Plan (2011-2031) (incorporating partial update of 2022) Adoption Statement

**The Planning and Compulsory Purchase Act 2004

Notice is given that on 26 January 2023 Wyre Council adopted the Wyre Local Plan (2011-2031) (incorporating partial update of 2022).

Subject matter and area covered: The Wyre Local Plan (2011-2031) (incorporating partial update of 2022) (the “Local Plan”) covers the whole of the Borough for the period 2011-2031. It provides the statutory planning framework for the Borough for non-minerals and waste matters. It is a revised replacement for the Wyre Local Plan (2011-2031) retaining all of its policies except those revised by the partial update.

Examination: The Submission Wyre Local Plan (2011-2031) (incorporating partial update of 2022) was submitted to the Secretary of State on the 25 April 2022. An independent inspector was appointed by the Secretary of State to conduct an Examination into the soundness and legal compliance of the Local Plan, including the Duty to Co-operate.

Modifications: The Inspector’s Report of the Examination was issued on 21 December 2022. The Report concluded that the Local Plan is legally compliant and, with specific Main Modifications, is sound. The adopted Local Plan incorporates the Main Modifications recommended by the Inspector, together with additional (minor) modifications made by the council that do not materially affect the policies in the Local Plan. Availability: The adopted Wyre Local Plan (2011-2031) (incorporating partial update of 2022), the Sustainability Appraisal Report (including Non-Technical Summary) and the Sustainability Appraisal Post Adoption Statement can be viewed and downloaded at www.wyre.gov.uk/adopted-local-plan

Challenge: Any person who is aggrieved by the adoption of the Local Plan may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that:

- a) The document is not within the appropriate power; and/or
- b) A procedural requirement has not been complied with.

Any such application must be made no later than six weeks from the date on which the Local Plan was adopted.
