1. Background to the Review

Local authorities must review their polling districts and polling places for UK parliamentary constituencies at least once every five years.

Compulsory reviews must be started and completed within the period of 16 months, beginning on the 1st of October every fifth year after the 1st of October 2013.

The relevant legislation can be found in section 16 of the Electoral Administration Act 2006 (as amended), the Representation of the People Act 1983 and The Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006. Guidance is also published by the Electoral Commission.

The Council's last full review was carried out in 2019 and was approved by the Council in March 2020.

2. Definitions

| Parliamentary Constituency | Parliamentary constituencies are the boundaries in place for UK parliamentary elections. These constituencies cannot be changed by the review. |
|----------------------------|--|
| | It is the division of the constituency into polling districts and places that is the subject of the review. |
| Polling District | A polling district is an area created by the sub-division of a UK Parliamentary constituency for the purposes of a UK Parliamentary election. |
| | In England, each parish must be a separate polling district, although larger parishes can be divided into two or more polling districts. |
| | A parish must not be in a polling district which has a part of different parish within it, or any un-parished part of the local authority area within it. |
| Polling Place | A polling place is the building or area in which a polling station(s) is located. |
| | A polling place within a polling district must be designated so that polling stations are within easy reach of all electors from across the polling district. |
| Polling Station | A polling station is the room or area within the polling place where voting takes place. |
| | Unlike polling districts and polling places which are fixed by the local authority, the responsibility of the allocation of polling stations is only that of the Returning Officer. In the case of Wyre Council, the Returning Officer is the Chief Executive. |
| | The scope of this review does not include that of the allocation of polling stations. |

3. Scope of the Review

The scope of the review and what the Council must consider as part of the review process includes the following:

- The designation of polling districts.
 - We must ensure that each parish is a separate polling district, although larger parishes may be divided into two or more districts where appropriate.
 - We must ensure that polling districts have appropriate elector numbers and are not too large where practical.
- The designation of polling places for each polling district.
 - We must designate a polling place for each polling district unless special circumstances apply.
 - Polling places must be an area within the polling district unless special circumstances apply.
 - A polling place must be of appropriate size and where practical, be in easy reach of all electors.
 - Accessibility requirements must also be considered when designating polling places.

The review does not cover the following:

- Changing of ward or constituency boundaries or names, which are the responsibility of the Local Government Boundary Commission (for wards) and the Boundary Commission for England (for constituencies).
- The allocation of polling stations, this decision is reserved solely to the Returning Officer.

The Council is required to publish a notice of the holding of a review.

The consultation document will also be sent to the local Members of Parliament, County, Borough, Town and Parish Councillors, local political parties and groups. It will also be sent to persons who have a particular expertise in relation to access to premises or facilities for persons who have different forms of disability. The consultation period for this review will conclude at 5pm on Friday 29 November 2024.

6. Representations

Consultees

The Council is required to consult the Returning Officer for every parliamentary constituency that is wholly or partly within its area.

We have consulted with Lancaster City Council and Fylde Council on the relevant polling districts and polling places which fall partly in their areas under the 'Lancaster and Wyre' and 'Fylde' parliamentary constituencies as they are the relevant Acting Returning Officers for this area. These comments will be published on our website alongside that of other representations throughout the review process.

This consultation document contains comments and proposals made by the Acting Returning Officer for Wyre Council on the 'Blackpool North and Fleetwood' parliamentary constituency and areas of Wyre that fall under the parliamentary constituencies of 'Lancaster and Wyre' and 'Fylde'.

We will also be consulting with the following directly to obtain comments regarding the review, this includes providing them with this consultation document:

- Members of Parliament for the 'Blackpool North and Fleetwood', 'Lancaster and Wyre' and 'Fylde' parliamentary constituencies.
- County, Borough, Town and Parish Councillors
- Town & Parish Councils
- Lancashire Police & Crime Commissioner
- Disability Groups

The consultation period for this review will conclude on 5pm, Friday 29 November 2024.

Making Representations

Any elector in the whole of the Wyre Council area may make representations to the Council.

Representations are also welcomed from persons who have expertise in relation to access to premises or facilities for persons who have different forms of disability.

We would encourage anyone making representations to suggest alternative polling districts/places to those proposed where appropriate and give reasons for the alternative.

All representations must be received by 5pm, Friday 29 November 2024.

All representations received will be published on the Council's website as soon as possible after the consultation closes.

7. Conclusion of the Review

Following the conclusion of the review final comments and proposals will be considered between $2 - 13^{th}$ December 2024.

The Council will consider the Returning and Acting Returning Officers comments and proposals, and any representations received during the consultation period to make a final decision.

The Council is required to give reasons for its decisions in respect of the designation of both polling districts and polling places.

Publication of the results of the review will be made available on our website on the 27 January 2025.

The Council must publish:

- All correspondence sent to the Returning and Acting Returning Officers in connection with the review
- All correspondence sent to any person whom the authority contacted because they had particular expertise in relation to access to premises or facilities for disabled people
- All representations made by any person in connection with the review
- The minutes of any meeting held by the authority to consider any revision to the designation of polling districts or polling places within its area as a result of the review
- Details of the designation of polling districts or polling places within its area as a result of the review, including the reasons for decisions (including where no changes have been made); and;
- Details of where the results of the review have been published.

8. Challenging the outcome of the Review

Following the conclusion of the review, certain persons have a right to make representations to the Electoral Commission to challenge/appeal the outcome. If, on receipt of such representations, the Electoral Commission finds that we did not:

- meet the reasonable requirements of the electors in the constituency, or a body of them (i.e. the reasonable requirements of a particular area of the authority have not been satisfactorily met); or
- take sufficient account of the accessibility to disabled persons of polling stations within a designated polling place.

They may then direct the Council to make any alterations to the polling places that they think necessary and, if the alterations are not made within two months, may make the alterations themselves.

9. Who may make a representation to the Electoral Commission?

The following may make representations to the Electoral Commission:

- An 'interested authority'. An 'interested authority' is the council of a parish, or where there is no such council, the parish meeting of a parish, which is wholly or partly situated within the constituency.
- Not less than 30 electors in the UK parliamentary constituency, in which the polling district and / or polling place that is the subject of the appeal is situated.
- Any person who made representations to the Council when the review was being undertaken (except the Returning Officer).
- Any person who is not an elector within a constituency in the authority's area, but who the Electoral Commission feel has sufficient interest in the accessibility of disabled persons to polling places in the area or has particular expertise in relation to the access to premises or facilities of disabled persons.

The Returning Officer may make observations on any representations made to the Commission.

WAC: Mobile units are far from ideal and tend to be used as a last resort when there is nowhere else available in the polling district. They do not provide an adequate footprint to accommodate a polling station. A thorough search of the polling district was done which gave the option to use the Three Lights public house. A visited was conducted and it was found to be a more than suitable venue for the purpose of voting. There is more than enough parking, access is all on one level both inside and outside. One side of the building can be closed off to the public allowing voters in WAC polling district to cast their vote.

WD1: No proposed change for this polling district.

WD2/WD3: Mobile units are far from ideal and tend to be used as a last resort when there is nowhere else available in the polling district. They do not provide an adequate footprint to accommodate one polling station, let alone double station in this case. The mobile unit is situated at the very top of polling district WD2 and whilst convenient for that polling district it is approximately 1.5 miles down to the bottom of polling district WD3. A thorough search of the polling districts was carried out and several options were considered:

| Option 1: | Fleetwood Hall Care Home, Chatsworth Avenue, FY7 8RW | The Manager confirmed there is not adequate space to meet our needs. |

| Option 4: | West View Health Village, Broadway, FY7 8GU | Initial enquiries were made but this is a large building with several business and health clinics operating within it. It's hard to distinguish between the different elements and this could cause confusion for voters. |
