NOTICE OF CASUAL VACANCY

SECTION 87 (2) - LOCAL GOVERNMENT ACT 1972 (AS AMENDED)

NOTICE IS HEREBY GIVEN that a casual vacancy is deemed to have occurred on Fleetwood Town Council due to the resignation of Cllr Jimilai Kuruvakadua.

Rule 5 of the Local Elections (Parishes and Communities) (England and Wales) Rules 2006, provides that on a casual vacancy occurring in the office of Town councillor, an election to fill the vacancy shall be held if within fourteen days* after the date of this notice (*i.e. **no later than 25 September 2026***) has been given in accordance with section 87(2) of the Local Government Act 1972, notice in writing of a request for such an election has been given to the Proper Officer of the borough council by **TEN** registered electors for the Township.

If a request for an election is not received by the deadline above, Fleetwood Town Council will arrange to co-opt a person to fill the vacancy as soon as practicable, in accordance with the Local Elections (Parishes and Communities) Rules 1986.
